SEPA Threshold Determination of Nonsignificance (DNS) FILE - SEPA15-011 / Water Systems Plan 2015

Date: July 23, 2015

To: Washington State Agencies, Tribes, local governmental agencies and community groups

Pursuant to Washington State Environmental Policy Act (SEPA), the City of Dayton is issuing this Notice of SEPA Threshold Determination of Nonsignificance (DNS).

Description of Proposal: The 2015 Water System Plan for the City of Dayton, WA, is a document covering all aspects of the City's water system. The plan includes projected water demands for the next 20 years (2014-2034) and identifies capital improvement projects that are needed over the next 20 years to meet the needs of Dayton. The plan covers physical facilities (wells, reservoirs, waterlines), operational plans, source water protection, financial status of the water system, and projected costs of the improvements. The area covered under this plan is the City's existing, retail, future, and water rights place of use water service areas.

Location: Water System Area Wide - Dayton, WA (see map attached) The location of the proposal encompasses the City's existing, retail, future, and water rights place of use water service areas. The above water service areas include the City limits, the majority of the Urban Growth Area (UGA), and existing services outside the UGA. Portions of the UGA were excluded from the City's water service areas due to existing topography and water features.
